## STATE CONSTITUTIONAL AMENDMENTS

**Question 1:** Renames the Maryland Court of Appeals to the Supreme Court of Maryland and renames the Maryland Court of Special Appeals to the Appellate Court of Maryland.

**Question 2:** Amends the Maryland Constitution to require that state legislators reside in and maintain a place of abode in the legislative district in which they wish to represent for six months prior to the date of election.

**Question 3:** Amends the Maryland Constitution to increase the amount in controversy in civil proceedings in which the right to a jury trial may be limited by legislation from \$15,000 to \$25,000.

**Question 4:** Amends the Maryland Constitution to legalize adult-use recreational marijuana and direct the legislature to pass laws for the use, distribution, regulation, and taxation of marijuana.
